## EXPLANATORY STATEMENT

---

This Explanatory Statement has been prepared for the information of the Shareholders in connection with the business to be conducted at the General Meeting to be held at 12.00 noon (EST) on 8 September 2011 at RSM Bird Cameron, Level 12, 60 Castlereagh Street, Sydney NSW 2000.

This purpose of this Explanatory Statement is to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions in the Notice of Meeting.

---

### 1. RESOLUTION 1 – RATIFICATION OF PRIOR ISSUE – SHARES

#### 1.1 General

As announced in June 2011, the Company issued 6,153,856 Shares at an issue price of 9.75 cents each to raise \$600,000 pursuant to a placement (**Share Placement**).

The Company entered into a mandate agreement with Intersuisse Limited, and its associated corporation, Phillip Capital Pty Ltd (together, **Intersuisse**) pursuant to which Intersuisse agreed to place the Shares the subject of the Share Placement to its sophisticated investor clients (**Mandate Agreement**).

The subscribers pursuant to the Share Placement were not related parties of the Company.

Resolution 1 seeks Shareholder ratification pursuant to ASX Listing Rule 7.4 for the issue of the Shares the subject of the Share Placement (**Share Ratification**).

ASX Listing Rule 7.1 provides that a company must not, subject to specified exceptions, issue or agree to issue more equity securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary securities on issue at the commencement of that 12 month period.

ASX Listing Rule 7.4 sets out an exception to ASX Listing Rule 7.1. It provides that where a company in general meeting ratifies the previous issue of securities made pursuant to ASX Listing Rule 7.1 (and provided that the previous issue did not breach ASX Listing Rule 7.1) those securities will be deemed to have been made with shareholder approval for the purpose of ASX Listing Rule 7.1.

By ratifying this issue, the Company will retain the flexibility to issue equity securities in the future up to the 15% annual placement capacity set out in ASX Listing Rule 7.1 without the requirement to obtain prior Shareholder approval.

#### 1.2 Technical information required by ASX Listing Rule 7.4

Pursuant to and in accordance with ASX Listing Rule 7.5, the following information is provided in relation to the Share Ratification:

- (a) 6,153,856 Shares were allotted;
- (b) the issue price was 9.75 cents per Share;
- (c) the Shares issued were all fully paid ordinary shares in the capital of the Company issued on the same terms and conditions as the Company's existing Shares;

- (d) the Shares were allotted and issued to sophisticated investor clients of Intersuisse. No Shares were issued to any related parties or associates of the Company; and
- (e) the funds raised from this issue are being used to accelerate drilling programs at the drill programs at the Bacchus Marsh Coal Project, Granite Castle Gold Project and Barkly Phosphate Project and for working capital.

## **2. RESOLUTION 2 – RATIFICATION OF PRIOR ISSUE OF SHARES TO AZALEA CONSULTING PTY LTD**

### **2.1 General**

Since the last meeting of Shareholders the Company has issued 210,603 Shares to Azalea Consulting Pty Ltd (**Azalea**), as an alternative to the payment of cash remuneration in relation to company secretarial services for the period from 1 October 2010 to 30 June 2011.

Azalea is not a related party of the Company.

Resolution 2 seeks Shareholder ratification pursuant to ASX Listing Rule 7.4 for the issue of those Shares (**Azalea Share Ratification**).

A summary of ASX Listing Rules 7.1 and 7.4 is set out in Section 1.1.

By ratifying this issue, the Company will retain the flexibility to issue equity securities in the future up to the 15% annual placement capacity set out in ASX Listing Rule 7.1 without the requirement to obtain prior Shareholder approval.

### **2.2 Technical information required by ASX Listing Rule 7.4**

Pursuant to and in accordance with ASX Listing Rule 7.5, the following information is provided in relation to the Azalea Share Ratification:

- (a) 210,603 Shares were allotted;
- (b) the Shares were issued as an alternative to the payment of cash remuneration for the provision of company secretarial services for the period from 1 October 2010 to 30 June 2011 and, as such the Shares were issued for nil consideration;
- (c) the Shares issued were all fully paid ordinary shares in the capital of the Company issued on the same terms and conditions as the Company's existing Shares;
- (d) the Shares were allotted and issued to Azalea Consulting Pty Ltd which is not a related party of the Company; and
- (e) no funds were raised from the issue.

**Instructions for Completing 'Appointment of Proxy' Form**
